Board Meeting Minutes

1. Approval of February meeting minutes
 - a. Motion to approve made by Damien; seconded by Mike
2. Treasurer's Report: Currently balance stands at \$12627.33 (this includes \$435 from PayPal). Does not include cash or PayPal for raffle tickets. Damien suggested moving forward that all money in the club account should be reported in totality, as opposed to breaking it down into men's funds & women's funds—we are one club and the funds are there to be used for all teams equally. This was agreed to by all board members. PayPal currently has \$429 for Midwest tickets. Mike and Damien will work on tax form for this year. Damien stated he still needs to follow up on previous year's records with Tim C. Motion to approve made by Mike; seconded by Tim F.
3. Midwest Raffle Update: Meg—5 tickets left unsold. Collected \$410 from players and sold 140 tickets while out and about in community. About half of the players have not returned tix/money. Made at least \$1000 on this so far.
4. Field Update: West Seneca Fireman's Park---Mike will submit COVID protocol and sign agreement. Matt also looked into Front Park, but the field is not playable. We will focus on using Fireman's Park for now, while we look at other possibilities in the near future. Mike, Matt, & Meg will meet at the field on Saturday to have a look at the layout/conditions.
5. Any Other Business
 - a. Goal posts—Matt reached out to the group that built the ones for CYC. Hoping to hear back soon. Also reached out to Buffalo Brew Fabrication and waiting to hear back on cost.
 - b. Logo update—Mike is going to check in on Seamus' progress so we can make a decision soon and have enough time to order new gear/jerseys.
 - c. Sullivan's will sponsor the team for \$3000 for 2021.



- d. NYPD home & away series---Matt is talking with Brian Green, etc and will schedule this. May/Sept-Oct
 - e. Registration is open for USGAA, so we can open ours—notices will go out and we will push players to register by March 31st. \$20 for club/\$42 for USGAA women/\$63 for USGAA men. The club will give t-shirts to all registered members.
 - f. Grace Foley will interview any willing board members for a project she is doing with St. Bonaventure.
 - g. FB ads for recruitment---Meg asked for ideas about wording for potential ads and for officers to send her material to post out regularly.
 - h. Running around Delaware Park for pre-season—this will take place on Tuesday nights at 630pm
 - i. Golf—Damien discussed Glen Oak as a possibility and will get a price from them. We are planning on August 28th for the tourney.
